The U.S. Department of Agriculture (USDA) invites offers to sell Dried Fruit pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance

Programs. Acceptances will be announced by midnight, August 15, 2016. Deliveries are to be made between October 1, 2016 and December 31, 2016.

Per FDA regulations, the following minimum mandatory labeling requirements for all foods, whether sold or donated, must appear on the label: Name of the food, Manufacturer's name and location, Net weight of the product, Ingredients list, and Allergen declaration. 
