The U.S. Department of Agriculture (USDA) invites offers to sell Bottled Juice pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, February 8, 2018. Deliveries are to be made between April 1, 2018 and June 30, 2018.


