Vendors are required to submit all questions no later than the deadline specified above. **Untimely question submissions may not be answered.** Answers to questions will be issued in writing via an amendment to the solicitation.

OFFER DUE DATE: Bids must be entered into WBSCM no later than **1:00 pm Central Time, Tuesday, June 19, 2018.**

- 2) All contracts issued will be IDIQ contracts and orders will be placed through the issuance of individual delivery orders in accordance with the terms and conditions listed in this document. The Minimum Quantity will be equal to approximately one full truckload; the Target Quantity is the amount that AMS anticipates purchasing based on current demand; the Maximum Quantity is the Target Quantity increased by twenty percent (20%). AMS anticipates making multiple awards from each line item without exceeding the offerors’ identified delivery constraints. Therefore, award may be made to an offeror for all, some, or none of the NTE quantities identified for each line item.

Delivery orders in excess of the constraint levels identified by offerors will be issued only by mutual agreement between the Government and the contractor. The Government anticipates purchasing the Target Quantity. However, the contractor is cautioned that the Government does not guarantee that any quantities in excess of the Minimum will be ordered under this contract.

Award will be made by individual CLIN based on each offeror’s pricing, delivery constraints per material, and delivery periods identified in the offeror’s bid.

- 3) Offerors may enter constraints, to include the total maximum number of truckloads for the life of the contract. The offeror may also enter constraints for specific delivery periods within the overall period of performance. Offerors must indicate constraints for delivery periods in which no shipments can be made by entering a constraint of zero, “0”. If no constraints are entered, AMS will interpret this to mean that the offeror is in no way limited in its capacity to deliver up to the total amount solicited for that delivery period.

- 4) Offerors will submit a unit price in WBSCM, for delivery to each State, inclusive of **all costs associated through final delivery**, for the contract line items (CLINs) they wish to offer. CLINs are identified in the Part B document attached to the solicitation. Offerors are required to enter a price for each and every state.

Note: State pricing entered shall be the same for all delivery points within each State and be inclusive of all delivery charges, including multiple stops loads. Trucks may have from one to three delivery stops. If multiple delivery stops are required and some of the stops are in different States, the portion of the load being delivered within each State shall be at the price applicable to that State.

In cases where constraints limit the lowest price offeror for a CLIN to an award volume that is lower than the full solicitation volume, the Government intends to meet its full requirement by awarding the remaining volume to the qualified offeror with the next lowest price. The Government reserves the right to make multiple awards.

- 5) USDA will accept product produced in calendar year 2018 and calendar year 2019 for deliveries made under resulting contracts. Product must be produced according to the applicable Commodity Specifications for (see Exhibit 3) and meet the requirements within.
- 6) Canned products will be accepted for up to 18 months from the date of inspection.
- 7) The requirements for checkloading by USDA inspectors outlined in the Commodity Specifications for frozen vegetables are NOT applicable to contracts awarded under this solicitation, for the following products ONLY:

Frozen Corn CTN-30 LB (Material 100348) and Frozen Green Peas CTN-30 LB
(Material 100350)

- 8) When delivery instructions state that the contractor's commodity is to be trans-loaded at load port into a 40' Ocean Container, the contractor is required to configure the commodity being shipped on no more than 20 pallets. If the contractor is shipping in a trailer larger than 40', they are also required to meet the aforementioned configuration requirement. If the contractor fails to follow these instructions, any damage or charges incurred will be at the contractor's expense, no exceptions. This includes damage due to improper blocking or bracing during transit and charges for re-stacking/re-configuration of pallets.
- 9) Some ports may charge wharfage fees. Offerors are responsible for researching and paying all costs associated with transportation fees including wharfage fees.
- 10) Delivery shall be:
 - a) FOB Destination;
 - b) Inclusive of all transportation costs, including multiple stops;
 - c) Within the period specified in each delivery order. (Delivery orders will be issued for two half-month delivery periods at a time at least 45 days prior to the first day of the first delivery period. Half-month periods will be between the first through fifteenth of the month or the sixteenth through the end of the month.) Also, the contractor shall provide an Advance Ship

Notice (ASN) in compliance with the Master Solicitation for Commodity Procurements (April 2017); and

- d) Within the states identified in the schedule with specific delivery locations identified in each delivery order.

11) Period of Performance: The period of performance under this contract is January 1, 2019 through 06/30/2019.

12) Place of Acceptance: Final acceptance of the product shall be at the destination specified under the contract/purchase order.

Note: Due to the recent changes in SAM.gov policy regarding the appointment of an authorized Entity Administrator, USDA/AMS may allow bidders to be considered for award pending SAM.gov processing of the notarized letter. This exception is considered for new/expired SAM registrations impacted by notarized letter processing delays only. - (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. (c) If mailed, a delivery order or task order is considered “issued” when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or be electronic commerce methods only if authorized in the Schedule.

4) **FAR 52.216-19 Order Limitations (OCT 1995)**

(a) *Minimum order.* When the Government requires supplies or services covered by this contract in an amount of less than **1 Truckload per half-month delivery period**, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) *Maximum order.* The Contractor is not obligated to honor –

(1) Any order for a single item in excess of **the amount indicated on the contractor’s 2-week delivery period constraints schedule;**

(2) Any order for a combination of items in excess of **the amount indicated on the contractor’s 2-week delivery period constraints schedule;** or

(3) A series of orders from the same ordering office within **_15_** days that together call for quantities exceeding the limitation in subparagraph (b)(1) or (2) of this section.

(c) If this is a requirements contract (*i.e.*, includes the Requirements clause at subsection 52.216-21 of the Federal Acquisition Regulations (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum-order limitations in paragraph (b) of this section.

(d) Notwithstanding paragraphs (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within **_3_** days after issuance, with written notice stating the Contractor’s intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the Government may acquire the supplies or services from another source.

Note: All delivery orders will be in full-truckload quantities. Some truckloads may require one to three stops.

5) **FAR 52.216-22 Indefinite Quantity (OCT 1995)**

(a) This is an indefinite-quantity contract for the supplies or services specified and effective for the period stated, in the Schedule. The quantities of supplies and services specified in the Schedule are estimates only and are not purchased by this contract.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. The Contractor shall furnish to the Government, when and if ordered, the supplies or services specified in the Schedule up to and including the quantity designated in the Schedule as the “maximum.” The Government shall order at least the quantity of supplies or services designated in the Schedule as the “minimum.”

(c) Except for any limitations on quantities in the Order Limitations clause or in the Schedule, there is no limit on the number of orders that may be issued. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(c) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor’s and Government’s rights and obligations with respect to that order to the same extent as if the order were completed during the contract’s effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after **45 days following the end of the effective period of this contract.**

6) **FAR 52.216-27 Single or Multiple Awards (Oct 1995)**

The Government may elect to award a single delivery order contract or task order contract or to award multiple delivery order contracts or task order contracts for the same or similar supplies or services to two or more sources under this solicitation.
