The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. Acceptances will be announced no later than midnight, Monday, July 30, 2018. Deliveries are to be from September 1, 2018 to September 30, 2018.

Ground Beef 1-pound packages shall be delivered within 30 days from date of pack.

Materials 100158 and 100159 are 50% Small Business Set Aside - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611 - Business size 1,000 employees or less apply to this requirement.
