This invitation for bids is part of the Food Purchase and Distribution Program under the authority of the Commodity Credit Corporation (CCC), with the purpose to assist farmers in response to trade damage from unjustified retaliation. Funding for this purchase is under Section 5 of the CCC Charter Act. Acceptances will be announced by midnight, May 3, 2019. Deliveries are to be made between July 1, 2019 and September 30, 2019.

Offerors who place a bid on this solicitation are agreeing to ALL terms and conditions outlined in the MSCP, specifications, and other attached documents. Late bids will NOT be accepted. Modifications of bids after bid opening date will NOT be accepted. Failure to adhere to contract terms and conditions may result in Termination for Default.
