The U.S. Department of Agriculture (USDA) invites offers to sell Tree Nuts pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, Friday August 16, 2019. Deliveries are to be made between October 1, 2019 and December 31, 2019.

This invitation for bids is part of the Food Purchase and Distribution Program under the authority of the Commodity Credit Corporation (CCC), with the purpose to assist farmers in response to trade damage from unjustified retaliation. Funding for this purchase is under Section 5 of the CCC Charter Act. Offerors who place a bid on this solicitation are agreeing to ALL terms and conditions outlined in the MSCP, specifications, and other attached documents. Late bids will NOT be accepted. Modifications of bids after bid opening date will NOT be accepted. Failure to adhere to contract terms and conditions may result in Termination for Default.

In accordance with Federal Acquisition Regulation (FAR) 52.203-2 Certificate of Independent Price Determination (Apr 1985) (as found in the System for Award Management (www.SAM.gov) Representations and Certifications) offerors have certified that the prices in their offer have been arrived at independently, without, for the purpose of restricting competition, any consultation, communication, or agreement with any other offeror or competitor.

In accordance with procedures outlined in FAR Subpart 3.3-Reports of Suspected Antitrust Violations, 3.301 General, 3.301, suspicion of collusive activities shall result in a rejection of the offeror(s) by the Contracting Officer.
