The U.S. Department of Agriculture (USDA) invites offers to sell Section 32 chicken products pursuant to the AMS Master Solicitation for use in Federal food and nutrition assistance programs. Acceptances will be announced by midnight, Wednesday August 21, 2019. Deliveries are to be made between September 16, 2019 and January 31, 2020.

This Solicitation includes the following changes to the FPPS for Chicken Parts dated July 2018:

Thighs (100879) # Frozen chicken thighs with back portion. Thighs shall be produced from ready-to-cook broiler/fryer chickens that weigh 4.0 to 6.5 pounds without neck and giblets. The commodity shall be packed in a minimum of four plastic-film bags and packed 40 pounds net weight in each fiberboard shipping container, with 1,000 containers per purchase unit totaling 40,000 pounds.

USDA Grademark # U.S. Grade A shall appear on the Master Case or each package and shipping container.

The above product definitions contain changes to the commodity specification that shall take precedence throughout the entire commodity specification.

Offerors who intend to use more than one processing plant and shipping point for contracts awarded under this solicitation, other than the processing plant and shipping point entered in their bids, may submit a list of their approved processing plants and shipping points on a separate sheet of paper to be uploaded in WBSCM, and to be submitted with their bids.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three. 
