QUALITY ASSURANCE

A. Raw Shelled Peanuts purchased for this Domestic Commodity Invitation shall be:

1. Graded by United States Department of Agriculture (USDA), Agriculture Marketing Service (AMS), or their official agents. An AMS Milled Peanut Inspection Certificate is required.
2. USDA, AMS Transfer Clearance Certificate (Peanuts) for all hopper rail shipments.
3. Check-loading Certificate from AMS or an AMS approved inspection agency for all truck shipments.
4. Tested for aflatoxin by a USDA laboratory or a USDA-Approved laboratory. Aflatoxin not to exceed 15 parts per billion (ppb). Certificate Required.
5. All Raw Shelled Peanuts awarded under this Solicitation must be fumigated during the Calendar months of May through November.

WEIGHT REQUIREMENTS

The permissible variation shall be limited to plus or minus 0.5%. This variation shall apply to the WBSCM Purchase Order item quantity (i.e. net weight)
