The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. Acceptances will be announced no later than midnight, December 06, 2019. Deliveries are to be from February 01, 2020 to February 29, 2020.

Ground Beef 1-pound packages shall be delivered within 30 days from date of pack.
