The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. Acceptances will be announced no later than midnight, December 20, 2019. Deliveries are to be from March 01, 2020 to March 31, 2020.

Ground Beef 1-pound packages shall be delivered within 30 days from date of pack.

Material 100158 is 50% Small Business Set Aside - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611 - Business size 1,000 employees or less apply to this requirement.

The Solicitation may show multiple stops on some line items, however, the number of stops will be limited to a maximum of three.
