The U.S. Department of Agriculture (USDA) invites offers to sell Frozen Fruit Juice pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, August 10, 2020. Deliveries are to be made between October 1, 2020 and December 31, 2020.
