This invitation for bids is part of the Food Purchase and Distribution Program under the authority of the Commodity Credit Corporation (CCC), with the purpose to assist farmers in response to trade damage from unjustified retaliation. Funding for this purchase is under Section 5 of the CCC Charter Act. Acceptances will be announced by midnight, August 21, 2020. Deliveries are to be made between October 1, 2020 and December 31, 2020.

In accordance with Federal Acquisition Regulation (FAR) 52.203-2 (as found in SAM.gov representations and certifications) offerors have certified that the prices in their offer have been arrived at independently, without, for the purpose of restricting competition, any consultation, communication, or agreement with any other offeror or competitor. In accordance with procedures outlined in FAR 3.301, suspicion of collusive activities shall result in a rejection of the offeror(s) by the contracting officer. This Solicitation includes the following changes to the FPPS for Chicken Fajita Strips dated April 2016.

Chicken Fajita Strips (100117) # Frozen, fully cooked, dark meat chicken fajita strips, produced from ready-to-cook boneless, skinless drumsticks, thighs, and/or legs. The commodity shall be packaged 5 pounds per plastic-film bag to a net weight of 30 pounds in each fiberboard shipping container. A purchase unit shall consist of 1,300 shipping containers totaling 39,000 pounds.

Potential contractors are not required to submit a production plan or sample prior to bidding.

Requirements # Inspection for final contract compliance shall be made by the Contractor, in accordance with 7 CFR § 70, FSIS regulations, and this FPPS. The quality, quantity, weight, packaging and packing of the commodity shall be evidenced by a Certificate of Conformance that verifies the designated commodity to be shipped meet s all the requirements as stated in this FPPS, MSCP-D and Solicitation.
