The materials were purchased on an f.o.b. destination basis. Deliveries are to be made from January 1, 2021, through March 31, 2021.

There were 14,760 cases of Blueberry Wild FRZ CTN-30 LB (100243) & Blueberry Wild FRZ CTN-8/3 LB (100242) that were not awarded due to no bids received.
