The U.S. Department of Agriculture (USDA) invites offers to sell Canned Fruit pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, February 16, 2021. Deliveries are to be made between April 01, 2021 and June 30, 2021.
