Checkloading: The requirements for checkloading by USDA inspectors outlined in the Commodity Specifications for canned and frozen fruit are NOT applicable to contracts awarded under this solicitation.

Acceptable pack years include: For products delivering in calendar year 2021, product produced in calendar year 2020 and 2021 will be accepted. For products delivering in calendar year 2022, product produced in calendar year 2021 and 2022 will be accepted.

Canned products will be accepted for up to 18 months from the date of inspection.

**CONSTRAINTS**

If applicable, constraints must be entered in truckloads NOT cases, pounds, etc. Constraints may overlap by product and delivery window. If an offeror has no constraints for a given product, they are not required to enter constraints.
