The U.S. Department of Agriculture (USDA) invites offers to sell WHOLE EGGS AND EGG PATTIES pursuant to the AMS Master Solicitation for use in the Federal food and nutrition assistance programs. Acceptances will be announced by midnight, August 5, 2021. Deliveries are to be made between October 1, 2021 - December 31, 2021.
