The U.S. Department of Agriculture (USDA) invites offers to sell Oven Roasted Chicken pursuant to the AMS Master Solicitation for use in the Federal food and Nutrition Assistance Programs. Acceptances will be announced by midnight, July 01, 2022. Deliveries are to be made between August 1, 2022 and April 15, 2023.

TENDERING TEXT FOR CHICKEN PRODUCTS

This Solicitation includes the following changes to the FPPS for Oven-Roasted 8 Piece Cut-Up Chicken dated July 2017:

Oven-Roasted Chicken (110080) shall be produced from ready-to-cook broiler/fryer chicken carcasses without neck and giblets, weighing 3.0 to 6.0 pounds.

800#Final Examination of Packaged and Packed Commodity

Contractors may choose to perform contractor checkloading in lieu of grader checkloading. The AMS grader will still be present during production for certification compliance but is not required to be present during checkloading. A USDA Poultry Products Grading Certificate would not be issued or required to accompany the load. If contractor checkloading is chosen, the contractor shall be responsible for conducting the FPPS requirements under Section 850 Inspection and Checkloading including records to assure contract compliance.

851#Requirements # Inspection for final contract compliance shall be made by the Contractor, in accordance with 7 CFR § 70, FSIS regulations, and this FPPS.

852#Procedures # The quality, quantity, weight, packaging and packing of the commodity shall be evidenced by a Certificate of Conformance that verifies the designated commodity to be shipped meets all the requirements as stated in this FPPS, MSCP-D and Solicitation. Inspection records shall be complete and made available to USDA, as requested, to assure contract compliance. Contractor checkloading activity is subject to review by USDA, per QAD policy, at the cost of the contractor.

The contractor shall perform checkloading examinations as described in the FPPS at the time of shipment and issue a Certificate of Conformance which can be found in the MSCP-D. Contractor is also required to provide an acceptance document to accompany each shipment. Further details are found in the Bill of Lading Notations Section of the MSCP-D.

applicable production date. An AMS Grader or other authorized personnel under the supervision of the AMS Grader shall stamp one end of each shipping container online. If there is inadequate space available on either end of the shipping container, the stamp may be applied to a side of the container.

1011.2#A copy of the Contractor's Certificate of Conformance and Bill of Lading or the original USDA Poultry Products Grading Certificate issued at time of checkloading shall accompany each shipment.

Offerors who intend to use more than one processing plant and shipping point for contracts awarded under this solicitation, other than the processing plant and shipping point entered in their bids, may submit a list of their approved processing plants and shipping points on a separate sheet of paper to be uploaded in WBSCM, and to be submitted with their bids.

Purchases will be made on an f.o.b. destination basis to cities on this Solicitation. Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.
