The U.S. Department of Agriculture (USDA) invites offers to sell Chicken Fillets and Chicken Strips pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, November 15, 2022. Deliveries are to be made between January 1, 2023 and March 31, 2023.
