A01 - The purpose of this amendment is to extend the 'Offer Due' date from #November 15, 2022 to November 21, 2022. The "Acceptance Date" remains announced no later than midnight, November 28, 2022.

The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. Acceptances will be announced no later than midnight, November 28, 2022.

Deliveries are to be from January 01, 2023 to January 31, 2023.
