Slaughter cows and Slaughter bulls mostly steady, Feeder steers, heifers, and bulls lightly tested, Steer calves, heifer calves, and bull calves sharply, replacement cows steady. Supply included: 79% Feeder Cattle (7% Steers, 67% Heifers, 27% Bulls); 14% Slaughter Cattle (70% Cows, 30% Bulls); 7% Replacement Cattle (100% Bred Cows). Feeder cattle supply over 600 lbs was 6%.
