

**PURCHASE AWARD DESCRIPTION**

The Department of Agriculture (USDA) purchased chicken and chicken products as indicated below for distribution to the child nutrition and other related domestic food assistance programs for Fiscal Year 2018.

The purchase is the result of offers received in response to Solicitation No. 2000005118 dated December 4, 2017.

The materials were purchased on an f.o.b. destination basis. Deliveries are to be made from February 1-February 28, 2018.

Unawarded: A total of 180,000 pounds of Chicken Large Chilled-Bulk were not purchased due to no bids received; 504,000 pounds of Chicken Large Chilled-Bulk were not purchased due to change in recipient's demand; 72,000 pounds of Chicken Legs Chilled-Bulk were not purchased due to price considerations.
