The U.S. Department of Agriculture (USDA) invites offers to sell OVEN ROASTED CHICKEN PRODUCTS, pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Acceptances will be announced by Midnight, June 23, 2023. Deliveries are to be made between August 1, 2023 and April 15, 2024.

For the purposes of this rule, successful delivery is defined as product delivered on-time and in acceptable condition according to the terms and conditions of the contract. Any delivery problems directly attributable to the Government will not be held against the contractor.\* \*

grader will still be present during production for certification compliance but is not required to be present during checkloading. A USDA Poultry Products Grading Certificate would not be issued or required to accompany the load. If contractor checkloading is chosen, the contractor shall be responsible for conducting the FPPS requirements under Section 850 Inspection and Checkloading including records to assure contract compliance.

851...Requirements - Inspection for final contract compliance shall be made by the Contractor, in accordance with 7 CFR § 70, FSIS regulations, and this FPPS.

852...Procedures - The quality, quantity, weight, packaging and packing of the commodity shall be evidenced by a Certificate of Conformance that verifies the designated commodity to be shipped meets all the requirements as stated in this FPPS, MSCP-D and Solicitation. Inspection records shall be complete and made available to USDA, as requested, to assure contract compliance.
