Discussion

- **The notes from August 11, 2015** were approved with no changes
- **Assessment of Soil Conservation Practices.** The group discussed the status of this document and how to move it forward. Both the CACS and NOP feel this is an important topic, but at this time the NOP suggests delaying further work until it can provide more guidance and resources to the CACS. An alternative approach is for the NOP to work on this project in collaboration with the NRCS and to not have the CACS work on it. NOP suggested that the group consult with one of the new NOSB members as she has experience in this area and with the NRCS. The CACS will continue this discussion on the next call.
- **Worker welfare (JT).** The group discussed the potential of adding to the work agenda a project on addressing organic farm worker health and welfare. Several members acknowledged that this is a weakness of the organic standards, but felt that it does not fit under OFPA and therefore the USDA does not have authority to regulate this. The member suggested that the group develop a way to address the health of organic farm workers, perhaps in terms of food safety or contamination. Members felt that this was addressed elsewhere and by other agencies. Another

CACS member suggested a discussion document or position statement so the community knows that it is a topic of interest for the NOSB.

- **Calculating % organic in multi-ingredient products.** A member asked about the status of the document that was sent to the NOP on April 11, 2013. The Subcommittee members urged the NOP to move this forward as they constantly receive feedback from stakeholders regarding this topic. The NOP indicated that the draft guidance should be sent back to the CACS soon. Additionally, the following documents are also near completion: Post harvest handling, biodiversity guidance, and classification of materials.

Discussion

- **The notes from February 9** were approved with no changes.
- **Assessment of Soil Conservation Practices (SR).** The lead sent a draft summary document to the CACS members for review. The document included a comprehensive history of the work-to-date as well as suggestions for moving forward. The CACS will present a brief verbal overview at the spring 2016 NOSB meeting, and will enter the document into the official record during the meeting.
- **In-field, annual evaluations of inspectors (JR).** A member suggested a topic for the CACS work agenda regarding the NOP Instruction 2027 dated August 3 2013 (<https://www.ams.usda.gov/sites/default/files/media/2027.pdf>). As a longtime inspector, the member feels that the requirement for annual on-site inspector evaluations is not aligned with Sound and Sensible principles and could have a negative impact on organic certification. She feels that it is logistically complex, very expensive for certifiers, and it does not appear to give discretion to certifiers. A member added information from a Certifiers perspective in support of

this viewpoint. The CACS will submit a request to the NOP to add this to the work agenda as a discussion document for the fall 2016 NOSB meeting.

- **Calculating percentage organic in multi-ingredient products.** The NOSB asked for an update on the status of the proposed guidance document, in response to the NOSB 2013 recommendation. Guidance is currently under development, and the NOP asked for examples of issues that may be of concern. Members expressed concern about lack of consistency in verification of percentages, particularly for single ingredient products, which may be over 95% organic but lack documentation to prove this. Members also noted continuing problems in calculating percentages for liquid products such as soups or almond beverages.
- **100% organic label claim.** The NOP will send some information and links to prior NOSB work on this topic.

Discussion

- **The notes from March 8** were approved with no changes.
- **In-field, annual evaluations of inspectors update (NOP 2027) (JR).** The group discussed the issues and justification for why they are requesting this work agenda item regarding the requirement for yearly evaluations of inspectors. The NOP spoke with staff from the Accreditation and International Activities Division (AIA) briefly about the request from the CACS, as they have just revised this guidance. A member noted that the 2011 NOSB recommendation included a three-year review timeline, and it is unclear why the NOP did not adopt that recommendation. AIA will discuss this and provide feedback. The NOP feels that the requirement for annual in-field inspector evaluations are a critical part of certification quality management. Certifiers are supportive of the concept of field audits, and agree it is improving the system. However, they want more flexibility, and for it to be risk-based so the logistics will be less burdensome. Certifiers would appreciate more explanation of the specific problem this requirement is meant to address. . . The CACS feels strongly that it continue to explore this topic to glean feedback from the certification community. The CACS will draft a letter to NOP asking for clarification, and asked that someone from AIA to address their concerns on a future call.
- **Peer review of NOP by American National Standards Institute (ANSI).** The NOSB put forth a recommendation in 2014 for a peer review process, and the audit is underway. Two current

NOSB members have been approached about assisting with the audit, but are unsure if they will be selected. The audit is scheduled to be completed by August 2016, at which time ANSI will deliver a report to the NOP.

- **Other items. The CACS will** discuss future work agenda topics on the May call. A member suggested adding calls to the schedule if they add work agenda items and need more discussion time.

Discussion

- **The notes from April 12** were approved with no changes.
- **Instruction 2027: In-Field, Annual Inspector Evaluations Overview (ALL).** Cheri Courtney, director of the NOP's Accreditation and International Activities (AIA), joined the call to discuss the NOP 2027 Instruction, which is an instruction for personnel performance evaluations. NOP views the inspectors as extremely vital to organic integrity, and annual evaluations are both important and required. The group discussed the reasons and goals for yearly evaluations, and while all agree that in-field evaluations are critical, requiring them to be done yearly is seen by some as a burden to organic certifiers, both logistically and financially. The NOP is aware that reaching the goal of auditing 100% of inspectors each year is burdensome and is working with certifiers to attain this goal. During public comment at the April 2016 NOSB meeting, stakeholders suggested that evaluations be conducted using a risk-based method, as opposed to trying to reach a goal of 100 % evaluations every year. Members also discussed public comments, the need for data collection from the community, and consistency and uniformity across certifiers. Members were welcomed to contact AIA for additional questions or discussion. The next step will include reaching out to the Accredited Certifiers Association (ACA) with a request for data. The leads will update the CACS on the next call.
- **Notifying operators via their certifier of sunset materials that were not renewed at sunset (HB).** A member circulated a draft document with justification for adding this project to the CACS work agenda. The member feels there is a breakdown in communication between certifiers and organic stakeholders, and the message about sunset materials that are no longer

allowed in organic is not being adequately or systematically relayed. The group discussed the idea and need for this project and will reach out to the Accredited Certifiers Association (ACA) and other groups to see if this is necessary or useful. A member suggested an informal process of communication via the ACAs, which could be implemented much quicker than having the NOSB develop a recommendation for guidance or instruction from the NOP.

Discussion

- **The notes from May 10** approved with no changes.
- **Instruction 2027: In-Field, Annual Inspector Evaluations Overview (JR, SR).** The co-leads updated the group on the progress to date. They have received feedback and data from the Accredited Certifiers Association, Inc. (ACA) and continue to seek more data about inspectors and costs. The goal is to receive all data by mid-July so they can analyze it and draft a document to send to the NOP. A member indicated that the document will include an International perspective as well. Members discussed various other topics related to the inspector evaluation process, including the sharing of evaluations by certifiers, guidance on procedures and thoroughness of evaluations, considering whether the frequency could be reduced to once every 3 years, and templates currently in use for evaluations. Several members will seek additional information from the International Organic Inspectors Association (IOIA) and the Food Safety Community and will discuss this further on the next call. The CACS intends on presenting an oral report at the fall 2016 NOSB meeting.
- **Notifying operators via their certifier of sunset materials that were not renewed at sunset (HB).** The lead sought feedback from the certification community and received mixed opinions about the idea of operator notification. The intention behind this project was two-fold: to create consistency among certifiers, and to aid co-packers or larger operations by keeping them informed about changes to the National List. The lead feels that this would aid those who may

face a loss of certification due to non-compliance. Based on feedback from the community and other Subcommittee members, the group decided there was no support at this time to move ahead with this project and will not seek to add it to the work agenda.

- **Eliminating the Incentive to Convert Native Ecosystems into Organic Crop Production (HB).** The lead summarized the project idea for the members. The CACS discussed the complexity of the topic, and members were supportive of adding it to the work agenda as a discussion document. The CACS will request its addition during the next Executive call, July 8.

Discussion

- **The notes from August 9** were approved as written.
- **In-field, annual evaluations of inspectors disc doc (NOP 2027) (SR, JR).** One of the co-leads summarized the document and the group discussed it. A member suggested the addition of a question pertaining to parallel systems that may be in use by other organizations. If such systems are in use, they could potentially be used as a model or for reference. For example, Global GAP has a robust global system in place, and perhaps could be a useful source for risk assessment. Another member suggested two additional questions for the document: 1) regarding a minimum threshold for evaluations. (E.g. inspectors who do less than 10 inspections a year) could be exempt from yearly field evaluations and instead be evaluated on a less frequent basis supplemented by paper evaluations); and 2) If certifiers would share evaluations, especially for those inspectors who inspect for multiple certifiers, it could streamline the process and be less burdensome. A member noted that both of these approaches have been considered and the NOP has not been supportive. After some discussion and feedback on these questions, the CACS chose to move forward with the document as a means to gather more information without proposing specific solutions.

The lead will make some edits as discussed on the call and recirculate the document for review. The Chair will hold the vote will open to allow the absent member the opportunity to vote via email.

- **Eliminating the Incentive to Convert Native Ecosystems into Organic Crop Production (HB).** **The lead summarized the origination of this project.** It was requested by various stakeholders, and was originally a separate piece in the NOSB biodiversity recommendation. Because it involved treatment of land before organic certification, the NOP felt it would require a rule change. The goal of the project would be to prevent these lands from being destroyed in favor of organic production. The lead noted that because it takes 3 years to convert land to organic, it tempts people to utilize "pristine" lands to convert to organic. Members offered suggestions for the document which were addressed before and on the call and the group moved to a vote. The vote will remain open for absent member to vote via email. Members will provide additional feedback to the lead and the document will be modified and recirculated.
