1. PURPOSE

This program notice announces a new policy regarding the retention of Grain Inspection, Packers and Stockyards Administration (GIPSA)--Federal Grain Inspection Service (FGIS) program notices, directives, and handbooks, by FGIS field offices and official agencies.

2. EFFECTIVE DATE

This action is effective upon receipt.

3. BACKGROUND

FGIS field offices and official agencies are required to maintain a complete and uptodate set of FGIS program notice, directives, and handbooks. Since 1998, field offices and official agencies have been allowed to download new or revised FGIS issuances from the GIPSA website (www.gipsa.usda.gov) and maintain these issuances as electronicfiles, instead of hard copies. These electronic files were required to be stored on either computer hard drives, floppy disks, or some other suitable computer storage medium that allowed for easy retrieval by the user.

On July 1, 2003, GIPSA suspended printing and distributing of FGIS program notices, directives, and handbooks. Now, GIPSA posts all new or most currently-active FGIS program notices, directives, and handbooks on the <u>GIPSA website</u> so that persons with Internet access may view or download these issuances at their convenience. The issuances are posted in the PDF format, which allows them to be printed directly from the webpage.

GIPSA notifies FGIS field offices, official agencies, and other interested parties by email when a new program notice, directive, or handbook has been posted to the GIPSA website. The e-mail gives a brief summary of the new issuance and provides directions for viewing, printing, or downloading the issuance from the GIPSA website. Information about all new FGIS issuances are also provided in the current issues of the GIPSA News, a monthly newsletter that is sent to GIPSA offices, official agencies, and interested groups and individuals

4. POLICY

FGIS and official agency service points 1/ that have Internet access are not required to maintain printed or electronic copies of FGIS issuance (e.g. program notices, directives and handbooks) when those issuances are posted on the GIPSA website. Printed copies are required for all issuances which are not posted on the GIPSA website.

FGIS and official agency service points¹ that do not have Internet access must maintain printed or electronic copies of FGIS issuances that are specific to the nature of the duties performed at those locations.
