



Historical Graph of Inspection and Weighing Account




Historical Graph - Supervision of OAs Account

Fee Reviews

Grain Inspection & Weighing Fees – 86 FR 1475 dated 01/08/2021, published a 5% grain fees increase notice for Grain Fees for Official Inspection and Weighing Services Under the United States Grain Standards Act (USGSA) that were effective on January 1, 2021. FGIS is preparing the fee notification for fees effective on January 1, 2022.

Grain Supervision Fees – 86 FR 49466 dated 09/03/2021, published the reduced supervision tonnage fee of \$0.004 per ton. FGIS is preparing the fee notification for fees effective on January 1, 2022.

In accordance with Section 800.71(c) FGIS will perform a periodic review [sometimes referred to "right sizing the fees"] and adjust all fees as necessary to ensure they reflect the true cost of providing official service.

Rice Inspection Fees - 86 FR 20476 dated 04/20/2021, published the FY2022 fees effective 10/01/2021. FGIS is preparing the fee notification for FY2023 fees effective on October 1, 2022.

Commodity Inspection Fees – FGIS continues to review the commodity account and implementing cost saving measures, where possible. FGIS is drafting a plan to adjust the commodity fees to cover costs.

FGIS is also reviewing the percentage assessed to AMA Cooperators for program oversight to ensure the appropriate fees are assessed.
