USDA Produce GAP Harmonized Standard Checklist

Introduction

The U.S. Department of Agriculture's (USDA) Agricultural Marketing Service (AMS) has reorganized content of the USDA Produce Good Agricultural Practices (GAPs) Harmonized Food Safety Standards for ease of use and uniformity across our audit offerings. The reorganization mirrors many of the sections of the Harmonized Combined Standard hosted by United Fresh.

The Produce GAPs Harmonization Initiative is an all-industry effort that develops food safety GAPs standards and audit checklists for pre-harvest and post-harvest operations that are applicable to all fresh produce commodities, all sizes of on-farm operations, and all regions in the United States. The Initiative is a collaborative effort on the part of growers, shippers, produce buyers, government agencies, audit organizations, and other stakeholders. USDA incorporated the Produce GAPs Harmonized Food Safety Standard into its GAPs food safety audit program in 2011. AMS provides voluntary GAPs audit services to the specialty crops industry that verify that fresh fruits and vegetables are produced, packed, handled, and stored as safely as possible to minimize risks of microbial food safety hazards.

Updates to Standard and Checklists

1. Scopes

The Produce GAPs Harmonized Food Safety Audit is now comprised of four scopes:

- a. General Questions
- b. Field Operations and Harvesting
- c. Post-Harvest Operations
- d. Logo Use

2. Requirement Numbers

Each Requirement Number begins with a letter, which allows the Requirement to be traced to its scope, i.e., G (General Questions), F (Field Operations and Harvesting), P (Post Harvest Operations), and L (Logo Use). Requirement numbers in the 2018 Reorganized Harmonized Standard, and their associated requirement numbers from the previous Harmonized Standards can be found in Table 1.

3. Scope Completion Requirement

- a. The General Questions scope must be completed for every audit.
- b. Depending on the type of operation being audited, either one or both of the following must be completed: the Field Operations and Harvesting scope and/or the Post-Harvest scope.
- c. The Logo Use scope must be completed for any operation that intends to use the USDA GAP logo on its packaging or promotional materials.

4. Redundant Questions

Questions that previously were assessed in both checklist are now included only in one checklist.

Updates to Documentation Requirements

1. A new category of documentation, Risk Assessment (A), has been added.

Risk Assessment (A): A risk assessment is a process to identify potential hazards on a farm and/or packinghouse as well as the likelihood the hazards will impact the safety of fruits and vegetables. Risk assessments should be documented in the manner which best represents the operation and the type of risk assessment required. This may include a combination of WP and/or R documents.

The reorganized Harmonized Standard includes three different documentation types that may be necessary to be compliant with the Requirement: (1) Written Policies / Procedures / Plans (WP), (2) Records (R), and (3) Risk Assessments (A). Risk Assessments have always been a requirement of the Harmonized Audit, but were previously categorized as either a WP or R. This new category of documentation (Risk Assessment (A)) highlights the questions related to the auditee's performance of a Risk Assessment while allowing flexibility on how the assessment is documented, i.e., by WP, R, or both.

2. The documentation requirements have been updated to align with the Produce Safety Rule of the Food Safety Modernization Act (FSMA). Records that are required to demonstrate compliance with the Produce Safety Rule have been added to the documentation requirements for associated questions in the reorganized Harmonized Audit.

Updates to Acceptance Criteria

1. The acceptance criteria have been updated to expand the number of questions that must be answered as compliant in order to meet the USDA acceptance criteria. All Harmonized Audit requirements that align to a requirement of the Produce Safety Rule must now be assessed as compliant, if applicable, in order to meet the USDA acceptance criteria.
2. The checklist and standard now include a mandatory requirements column (MAN) to help auditors and auditees identify all factors that must be assessed as compliant.

MAN: A notation (●) in this column indicates the requirement is mandatory and must either be assessed as compliant (C) or not applicable (N/A) in order to meet USDA Acceptance Criteria.
